<u>ITEM 4</u> <u>REPORTS/DISCUSSION ITEMS</u>

Lisa Rao

a) Fundraising

L. Rao reported that fundraising protocol was not adhered to in a secondary school. P. Amos, Director of Education responded to this issue and also noted that the Ministry of Education has issued new fundraising guidelines. As soon as the Administration has perused them, the Board policy with regards to fundraising will be changed. Mrs. Amos will check into the matter of the fundraiser at the secondary school. Mrs. Amos also noted that staff have been approached by the press regarding fundraising, e.g. amount raised per school. She stressed the difference between school fundraising and school generated funds. Discussion ensued, followed by a question and answer period.

Patrick Daly

In Mr. Daly absence, Mrs. Amos reported on the following:

a) Mr. Daly has been elected to sit on the Board of Directors of the Ontario Catholic School Trustees' Association.

b) Budget

- There has been much in the press regarding the budget.
- Board budget will go to the Board of Trustees for approval on June 19, 2012.

There was a budget priorities survey posted on the Board web site for parents, employees, taxpayers to fill out and comment on. There were 613 responses and the survey showed that the two main priorities are safe and secure schools for the students, and special education.

c) Negotiations

All employee group contracts expire on August 31, 2012. There will be many things in the press and Mrs. Amos stressed that, if a Committee member is questioned regarding the negotiations or contracts, they should refer all questions and concerns to Mr. Daly. The Board has three very strong negotiators and this is a very fragile time.

Patricia Amos

a) Multi-Year Strategic Plan for Ministry of Education

Per the Ministry of Education, the multi-year strategic plan is for the life of the current Board of Trustees. Administration is now reviewing year 1. They will be looking at a number of items, including whether the Board accomplished what it set out to do. Please contact Mrs. Amos if you have any questions or concerns.

b) Staffing

The Administration is presently working through the staffing lists. School councils have input in the quality of principals and teachers. Mr. Ciapanna noted that a Ministry of Education handbook has been given to all principals with a questionnaire to be filled out by the Catholic School Councils. All principals should have a copy of the questionnaire, but anyone from the Catholic School Council can contact Mr. Ciapanna's office for a copy. Mrs. Amos stressed that the first concern of the Catholic School Council with regards to a principal, should be the qualities of the principal's Catholicity and how good of a Catholic leader the principal will be for the school.

c) Parent Engagement Strategy – Math (Ontario Focus Intervention Partnership)

The focus this year is numeracy. The Board has used money obtained from the Ontario Focus Intervention Partnership to acquire developmental math programs and provided information sessions for parents. The Board is also providing on line help with available tutors.

d) Respecting Home-School Relationships: Resolving Conflict Between Home and School

A Committee was formed to put together this protocol and the Committee would like CPIC's input. Mrs. Amos highlighted certain sections of the protocol and responded to questions from the Committee.

e) Upcoming Agenda Items

P. Amos noted that if there are any specific items that anyone on the Committee wishes to discuss, please contact her office or Mr. Ciapanna's office.

Corrado Ciapanna

a) Received a memo from the Ministry of Education promoting parent involvement. A kit was sent from the Ministry to all schools. School Councils can obtain a copy from the school principal.

b) CPIC By-Laws

According to the By-laws for the Catholic Parent Involvement Committee, the following must be followed:

- i) Co-Chairs must designate 1 Co-Chair with a one year term and the other Co-Chair with a two year term. The same must be done with parent representatives.
